FREE ROOM HIRE CONDITIONS

Free room hire is based on a 6-hour period and is dependent upon the following: a price per head food package must be ordered from the functions menu with the minimum numbers being: Monday to Thursday – 30 people (min food spend \$300) Friday, Saturday & Sunday – 30 people (min. food spend \$500)

DEPOSITS

In order to secure your booking a \$100 deposit is required at the time of the booking; no tentative bookings will be taken. Your booking is not confirmed until your deposit is received & you have returned a signed copy of the acceptance of the terms & conditions. All deposits are non-refundable once paid.

DECORATIONS

Please feel free to put decorations up for your function. Limitations do apply to avoid any damage to the function room. . NO glitter, sparkles or confetti of any kind are to be used. If you wish to us them, a \$100 cleaning fee applies. Please note that any functions in the Restaurant Herb Garden will need to cease at 10pm due to noise restrictions.

PAYMENT & FINAL NUMBERS

Final numbers & full payment of your function must be made 7 days prior to your event. Payment methods include AmEx, visa, MasterCard or cash. Credit card details are required in the case of property damage, theft or additional expenses that occur on the night. You will be notified prior to any expenses being charged to your credit card. Credit card details will be destroyed upon successful completion of your function.

MINORS

Given the tough licensing laws Aspley Hotel must adhere to, the following rules apply to anyone under the age of 18:

- All children must be in the company and immediate presence of a responsible adult at all times.
- Children are not allowed to be in the restroom on their own.
- Children are not permitted to stay in the hotel after 10:00 pm on any night

INTOXICATION & OFFENSIVE BEHAVIOUR

The venue has a strict policy on intoxication & offensive behaviour. Any person deemed to be intoxicated or behaving in an offensive manner will be asked to leave the premises. Please work with us in preventing this from happening.

SECURITY CHARGES

At the venues discretion a security guard may be required for your event at a cost of \$290 for 5 hours.

COMPLIANCE

If management has reason to believe that the behaviour of your guest(s) affects the smooth running of our venues business or reputation, we reserve the right to remove the individual(s) from the premises at any point before, during or after your function. We also reserve the right to shut down the function if the above is believed to be true.

18TH - 20th BIRTHDAYS

We currently do not host 18th - 20th birthdays.

BAR & BEVERAGE

Bar tabs may be arranged either in advance or on the night of the event. Bar tabs can be paid for either via cash or card. A credit card will need to be provided and held as security for the bar tab. Please be advised that the bar will close at 12.00am.

DAMAGES

You will be responsible for any damages caused by your guests and will be expected to pay for them promptly. Compensation from all third-party property damage will be your responsibility to pay for.

ALARMS & SMOKE DETECTORS

All areas of the hotel are fitted with smoke alarms including the function spaces. In the event that a person cause's activation to the fire alarm and the fire brigade attends the hotel the current call out fee is \$2,000.00 charged by the QLD fire brigade and they will not reverse their decision. The fee is the whole responsibility of the person who books the function and the fee will automatically be deducted off the credit card pre-authorisation.

WHAT YOU CAN BRING

Cakes & lollies. NO cheese, meats or dips.

ENTERTAINMENT

Own entertainment may be organised at the venue’s discretion. The venue reserves the right to control volume of all entertainment. Please speak to management to discuss entertainment options

FORCE MAJURE

Where matters beyond the reasonable control of the hotel prevent the venue and its staff from fulfilling their obligations under this contract, the client agrees to release the hotel from any liability or loss whether incidental or consequential to such matters.

CANCELLATIONS

Deposits are non-refundable from time of purchase. Any cancellations must be made in writing, to the hotel, a minimum of 14 days prior the function date. Any cancellations made within 7 days of the function date will be charged for catering.
